## POWER OF ATTORNEY FOR THE SALE OF CHOMETZ

I, the undersigned, fully empower and authorise Rabbi R Stepsky to act in my place and stead and, on my behalf, to sell any *Chometz* possessed by me (knowingly or unknowingly) up to and including **Friday 19<sup>th</sup> April 2019 at 11.30am** including any food in respect of which there is a doubt or possibility that it might contain *Chometz*, and all kinds of *Chometz* mixtures, and to lease all places wherein the *Chometz* owned by me is stored and found, especially in the premises specified below, or elsewhere.

Rabbi R Stepsky has full authority to sell or lease all *Chometz* and all places wherein the *Chometz* owned by me is found, by any transaction in any manner which he deems fit and proper, and for such time as he believes necessary, in accordance with the detailed terms and conditions set out in the agreed Contract or Sale which he will draw up. This authorisation is part of that Contract.

I also give Rabbi R Stepsky power and authority to appoint any proxy he deems fit in his place, with full power to sell or lease as provided herein.

The above-given powers are to be exercised in conformity with all Torah and Rabbinical regulations and laws, and also in accordance with the laws of the country.
